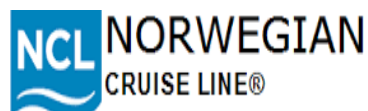

**RESERVATIONS AND PAYMENT:** A \$250 per person deposit and signed reservation form is required. **Final payment due January 11, 2019**

**CANCELLATION:** Passengers who cancel for any reason, including medical reasons, are subject to the following cancellation fees: 119-91 days before travel - 25% per person; 90-61 days before travel = 50% per person; 60-31 days before travel = 75% per person. No refunds will be given on any cruise for no-shows or cancellations that occur 30- 0 days prior to sailing day. Suites & Garden Villas: 119-106 days prior to sailing = 25% per person; 105-91 days prior to sailing 50% per person; 90-61 days prior to sailing 75% per person; 60-0 days prior to sailing 100%. No refunds will be made in the event of interruption or cancellation by any passenger after commencement of the cruise. In addition to the penalties stated above AAA cancellation fee of \$25 p/p member and \$35 p/p non-member will be assessed. We strongly recommend the purchase of trip cancellation insurance through your AAA travel agent.

**NOT INCLUDED:** Shore excursions, gratuities or other items not specifically stated in the cruise rate. Items of strictly personal nature such as bar beverages, phone calls, laundry, photographs are at your own expense.

**BAGGAGE:** You are allowed two pieces of checked luggage and one carry-on which must remain in the care of its owner at all times. Gratuities for baggage handling at ports are not included.

**TRAVEL DOCUMENTS: US citizens must carry a valid passport.** Non-citizens must have a valid passport and necessary visas. These documents are the traveler's responsibility.
